LIVING YOUR BEST LIFE OUTSIDE OF ALL HOMES - RULES AND <u>REGULATIONS</u>

Summary: The rules and regulations outlined here are a testament to our collective effort as a team to maintain the Waterman Village Community's charm and appeal for both current and future residents.

- These rules and regulations are designed to ensure that our community remains a
 pleasant and inviting place for all. All home residents are responsible for reading,
 understanding, and adhering to these rules and regulations. If you have questions or
 need assistance in interpreting these rules, remember that you can always contact
 Rosa Lesperance, Resident Relations Administrator, at ext. 294 or Alvin Smith,
 Director of Facility Operations, through his administrative assistant at ext. 251. The
 following is a partial list of yard care requirements. It is not meant to be an exhaustive
 list of all possible conditions and situations.
- 2. Any changes to the exterior of your home, including plantings, must be approved by the Waterman Village Facility Services at ext. 251. This ensures that our community maintains a uniform and appealing appearance: plantings, gardens, garden pots, hanging baskets. Plants must be planted in their original container or a pot specifically for that purpose. No words or pictures are permitted on pots/containers. Before replacing or installing any plantings, pots, or baskets, WV residents must obtain prior approval from Facility Services at ext. 251. Flower beds and gardens must present a neat appearance from the street and neighbors' views. The Waterman Village grounds department will remove dead plants/flowers. No tree, regardless of size, shall be removed from any portion of the community without the prior consent of Waterman Village. WV can limit the types, sizes, and quantity of plantings, pots, and baskets.
- 3. Christmas lights and decorations shall remain outdoors only from Thanksgiving **until January 15th** each year. Other seasonal lights, such as Halloween, shall stay outdoors for two weeks.
- 4. Only items manufactured and sold for outdoor use may be placed outside the house for seating, tables, dining, grilling, decoration, and bird feeding. All outdoor furnishings must be kept in good repair and clean condition. WV has the right to limit outdoor furniture types, sizes, and quantities.
- 5. Storage containers. The areas around the outside of each home are not to be used as storage areas at any time. One <u>horizontal</u> storage unit, specifically for storing

outdoor items, may be placed outside the house and must be approved by the WV facility services department (ext. 251). You can find these at Lowe's in the store or online. While it's preferred that they not be placed in front of the home, this is permissible.

- 6. Tarps are prohibited, and grill covers manufactured for that use do not require approval.
- 7. Flags (USA) are permitted and must be kept in reasonable condition without touching the ground. All other flags and banners require pre-approval from the WV facility services department.
- 8. Trash cans are not permitted outside of any home.
- 9. No gardening items or supplies, including, but not limited to, garden hoses, mulch bags, original nursery plastic pots, garden pots without living plants in them, bags of any type, tools, watering cans, may be left out in the front yard, or side of yard visible from the street, after immediate use. If not stored out of sight, garden hoses shall be kept coiled neatly under an exterior faucet or nearby in a container manufactured and sold for hose storage. Empty flower/plant pots are to be removed. Pots and baskets must be kept in good condition and not in need of repair or be broken.
- 10. Equipment and supplies used in outdoor projects and activities, including, but not limited to, any horticultural pursuits, vehicle maintenance, and furniture refinishing, shall not remain in any area that can be viewed from a street. <u>This includes buckets</u>, <u>plastic tubs</u>, <u>bins</u>, and <u>milk-type crates of any type</u>. Stepstools, walkers, scooters, and wheelchairs are not permitted to be stored outside when unused. A grill is permitted for non-apartment residences. The grill cannot be seen from any street. No camping equipment shall be set up for camping activity in any location or yard.
- 11. All garbage must be secured in a plastic garbage bag before being placed near the curb. On pick-up days, garbage shall be placed no earlier than 9 A.M. Newspapers, magazines, towels, and rags cannot be left outside when not in use.
- 12. Artificial vegetation shall not be permitted on the exterior of any property except for that used as a front door decoration.
- 13. WV facility services must approve Exterior sculptures, statues, wind chimes, lawn ornaments, fountains, flags, front porch swings, signage, and table umbrellas in advance.

- 14. No outbuildings, including, but not limited to, storage sheds and doghouses, are permitted on any home.
- 15. No exterior clotheslines of any type shall be permitted upon any lot.
- 16. A maximum of two bicycles may be stored out front and undercover (carport) when not in use.
- 17. No pet food, containers, or bed accessories are permitted outside the villa.

WV has the final discretion to place or remove any item outside a home at any time. When a resident is notified of a need to remove or replace an item, they will be notified in writing and given a designated number of days to comply with Waterman Village's requirement/request. If a resident is still non-compliant, Waterman Village may, at its discretion, remove, alter, or replace the item as deemed necessary.

ADDENDUM TO LIFE LEASE AND SERVICE RESIDENCY AGREEMENT

This Addendum to Life Lease and Service Residency Agreement (this "<u>Addendum</u>") serves as an addendum to that certain Life Lease and Service Residency Agreement entered into by and between _____

("<u>Resident</u>"), and **WATERMAN COMMUNITIES, INC.**, a Florida 501(c)(3) not-for-profit corporation ("<u>Waterman</u>"), dated ______, 202___, a copy of which is attached hereto ("<u>Standard Lease</u>").

A. Waterman and Resident entered into the Standard Lease (said Standard Lease together with this Addendum and all other addenda entered into in connection with the Standard Lease are hereinafter collectively referred to herein as the "Lease"), whereby Waterman leases to Resident, and Resident leases from Waterman, that certain residence located at Waterman Village or Lakeside at Waterman Village, both in Mount Dora, Lake County, Florida (the "<u>Residence</u>"), as more fully set forth in the Lease.

IN CONSIDERATION OF the foregoing facts, the mutual covenants, conditions and agreements set forth below, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Waterman and Resident hereby agree as follows:

1. <u>Special Provision</u>. The Lease is hereby amended as follows:

Contribution of Refund to Waterman Foundation. Notwithstanding anything to the contrary in Section 6 of the Standard Lease, entitled "Refund," Waterman and Resident hereby agree that upon termination of the Lease according to the terms of the Lease, Resident desires to donate to the Waterman Communities Foundation, Inc., a Florida 501(c)(3) not-for-profit from or corporation (the "Foundation"), \$ percent (%) of the refundable portion of the total Life-Lease Fee to be paid to Resident pursuant to Section 3 of the Lease (the "Contribution"). The Contribution shall be automatically deducted from the amount of the refundable portion of the Total Life-Lease Fee and paid to the Foundation simultaneously with the payment to Resident of the balance of the refundable portion of the Total Life-Lease Fee. Upon submitting the Contribution to the Foundation, Waterman or the Foundation shall provide the Resident and/or such other appropriate representative of the Resident ("Resident's Representative") with the written acknowledgment required by the Internal Revenue Service for Resident or Resident's Representative to quality for a charitable tax deduction.

2. <u>Definitions; Effect on Lease</u>. All capitalized terms in this Addendum, unless otherwise defined or modified herein, shall have the same meaning as set forth in the Lease. Except as modified herein, the Lease remains unchanged. In the event of a conflict between the Lease and this Addendum, this Addendum shall control and govern.

3. <u>Lease Ratified</u>. The terms and provisions of the Lease, as modified by this Addendum, are hereby ratified and affirmed by the parties hereto.

4. <u>Counterparts</u>. This Addendum may be executed in one or more counterparts, each of which shall be deemed an original, but all shall constitute one and the same Addendum; provided, however, this Addendum shall not be effective until fully executed by both parties.

5. <u>Applicable Law</u>. This Addendum shall be governed by and construed in accordance with the laws of the State of Florida.

Employee Appreciation Fund

While we have a "No Tipping Policy," we have a mechanism that allows you to reward all hourly staff (Managers do not participate). Consider if we did allow tipping and the number of persons you come in contact with that provide quality service, with a modest 10% tip, which could amount to nearly \$250 per month. Each year, money is collected and distributed to the employees just before Christmas. (No tax deduction) Residents and guests may contribute throughout the year to an "Employee Appreciation Fund." Donations to the fund can be submitted to the Accounting Department at any time during the year, or you may have your contribution added to your monthly bill by filling out the Employee Appreciation Donation form designating how you wish to participate. These forms are available from the Accounting Department. FIRE

In case of a fire in any apartment:

- 5. Wait for the Fire Department.

Fire Drills

The Village will routinely have fire drills in the Lodge, Lifestyle Center, Edgewater, Bridgewater, and Springwater for the safety of our residents and staff. These drills must keep residents and employees alert and familiar with our safety procedures.

TORNADO

In case of tornado warnings:

- 1. Listen to the radio (AM 790 WLBE) for tornado/severe storm advisories.
- 2. Have a flashlight and extra batteries on hand.
- 3. Close windows and window coverings (curtains, drapes, blinds, etc.)
- 4. If time allows, fill containers and bathtubs with water.
- 5. Use your telephone only for emergencies.
- 6. During a tornado, remain in your home away from windows, preferably in the main bathroom or in the shower/tub area with the door closed.

HURRICANE

A hurricane watch means hurricane conditions are a real possibility for the area.

- 1. Listen to the radio (AM 790 WLBE) for storm updates.
- 2. Prepare or update the hurricane kit. (Kit information to follow.)
- 3. Fill containers with water.
- 4. Close windows and all window coverings.
- 5. If you have an automobile, fill it with fuel in advance.
- 6. Please notify the Administration if you plan to leave the Village.

A hurricane warning is issued when a hurricane is expected in 24 hours. You will be notified of a hurricane warning through the Independent Living Management call system within 24 hours of an expected occurrence.

*****BEGIN PRECAUTIONARY ACTION AT ONCE*****

- 1. Bring lawn chairs and loose light objects indoors—Call for Heavier objects and help bring them in.
- 2. Use your telephone only for emergencies.

- 3. During a hurricane, if evacuation is not required, remain in your home away from the windows, in the main bathroom, or in the shower/tub area with the door closed.
- 4. Fill containers and bathtub with water.
- 5. Secure your pets in a safe area in your apartment.

IF EVACUATION TO THE BRIDGEWATER IS REQUIRED, WE WILL NOTIFY YOU WITH FURTHER INSTRUCTIONS.

A <u>hurricane evacuation kit</u> should include the following:

- Flashlight and radio with extra batteries
- First Aid kit
- 2-week supply of medications and toiletry items (toothpaste, brush, etc.)
- 3-day supply of non-perishable food. Any special dietary foods you require.
- \circ Bottled water (1 gallon per day, per person 3-day minimum)
- Cash or traveler's checks
- Blankets or sleeping bags
- Extra clothing and rain gear
- Personal items and important documents (ID, Social Security, Medicare, etc.)
- Non-electric (battery) clock and can opener

FIREARMS AND WEAPONS

- Waterman Village discourages our residents from possessing firearms and weapons within their Villa or Manor; however, we also respect each individual's choice and therefore recommend:
- Storing firearms and all other types of weapons off campus;
- If they are kept on campus, they should be stored in a manner that promotes safety, i.e., with a trigger guard, in a gun or weapon safe, and disassembled.
- All firearms should be stored and unloaded. Ammunition should be stored in a secure manner and separate from the gun.

If you choose to hire a private caregiver, please be aware that you are responsible for the worker's compensation insurance, income tax, and social security obligations.

Waterman Village has an outpatient therapy clinic for Independent Living residents, Bridgewater residents, and off-campus residents in the surrounding communities. Physical Therapy, Occupational Therapy, and Massage therapy are additional services offered as private pay services, and Speech Therapy can be utilized with an order from your physician.

Services include, but are not limited to, Neurological therapy, pain management, cardiac rehab, vestibular and balance rehab, orthopedic conditions, Parkinson's training (BIG/LOUD program), stroke rehab, low vision, cognition and swallowing problems, speaking and voice improvements, fall prevention, neuropathy, and so much more.

For additional service information, see the flyer in the Misc Info tab. We accept most insurances. Please call our clinic if you need any assistance.

HOME CHANGES

If a resident wishes to make a home change, the Village will accommodate this, pending availability. A home change will necessitate a new lease, and monthly residency fees will be increased to the rates currently charged to new residents moving into the Village. A moving/transfer fee of two months' rent will apply.

HOME UPGRADES

The resident shall pay for any approved upgrade changes made to a home. Upgrade charges are considered a contribution to Waterman Village and will not be refunded at any time. Please get in touch with the Move-In/Construction Coordinator at ext. 401 if you want an upgrade change.

HOME USE BY OTHERS

The resident's rights and privileges under the lease agreement to occupy the home and use the facilities and services are personal to the resident. They cannot be transferred, assigned, or willed to another individual by legal proceedings. No person other than the resident may occupy the accommodations covered by the lease agreement.

Due to the sensitive nature of the relationship between employees and residents, residents may not request special services from employees during their off-hours.

WOW Program

Waterman Communities, Inc. shall reward employees for outstanding customer service or going the extra mile through an employee benefit program entitled WOW.

- WOW postcards are awarded to our employees for going *above and beyond*, for their upbeat attitude, anticipating and meeting customer needs, accepting responsibility, responding with tact, showing initiative, and being willing to help others. WOWs are awarded at the discretion of the person issuing the postcard. A WOW postcard should be issued at no more than 5 Perks.
- Residents, family members, and fellow employees may nominate employees. The resident or family member can complete the postcard and send it to the Human Resources Department, which will mail it to the employee's home address.

No Tipping Policy

The Village has adopted a "*No tipping*" policy. Tipping could result in uneven service and harm the morale of the residents and staff. Kind words or letters of commendation, however, are always appreciated. Please remember that employees can be subject to termination if they accept tips or gifts.

Resident to Employee Sale of Property

If you wish to sell an item or personal property to an employee, you must complete a "Resident to Employee Sale of Property" form, available at the Oaks Lodge Receptionist.

INCIDENT REPORTING

Florida laws and our liability insurance require Waterman Village to be responsible for the safety and care of all residents. Florida law also requires that residents report all consequential incidents of illness or accidents to Security. Each resident is to decide whether the incident is of consequence. Should there be any doubt, it is best to report it.

INSURANCE

Waterman Village (Waterman Communities, Inc.) carries insurance on its buildings, equipment, and property and liability insurance for accidents in common areas. Residents are advised to secure a renter's policy that provides coverage for personal property, including golf carts and effects and personal liability. Please give the Independent Living Information Center with proof of insurance.

<u>KEYS</u>

You are issued keys to your home and mailbox. If you are locked out of your home, please go to the nearest reception area or the Guardhouse (ext. 382(Oaks) or 383(Lakeside)) so that Security may be dispatched promptly. Extra keys will be made at a cost.

LIBRARY

The Library is located in the Oaks Lodge or the Lakeside Grand, and a volunteer member of the Library Committee is available most mornings. Newly acquired hardback books may be borrowed for 14 days and all others for 30 days. Paperback books have no card and may be borrowed and returned at will.

To take out a hardback book, remove the card from the back, print your name and date on the card, and place the card in the basket on the table. When you return a book, put the book on the return cart inside the Library entrance on the right. If you'd like to reserve a book, a Reserve Requests notebook is on the table. Food or drink is not allowed in the Library.

Library Fund

This provides new subscriptions and books for the library, which the Library Committee and Activities manage.

LOST AND FOUND

Our Lost and Found are at the Lodge reception or Lakeside Grand desk. Please report lost items or turn in any found items to the Receptionist.

MAIL SERVICE

The Post Office will deliver mail Mondays through Saturdays to the Oaks postal box near each home building. It would be best to alert all correspondents of your home number and zip code. The red flag in the upright position indicates that the mail has been delivered. It is the resident's responsibility to lower the flag no later than 5:00 p.m. each day.

For Lakeside, the primary mail pavilion is located right outside near the Garden Homes. All Package deliveries are made to the Lakeside Grand Front Desk.

Postage stamps may be purchased at Publix Supermarket or Walgreens Pharmacy. Residents may also order stamps by giving the U.S. Post Office Letter Carrier that services Waterman Village a check for the applicable amount of stamps they want to order.

This may be done as follows:

- Enclose a check payable to USPS (for United States Postal Service) in an envelope with your return address and a note specifying how many stamps you want. The check must be for the exact amount of stamps you are ordering.
- Place the check in the Outgoing Mail section of the community postal box by your home.
- The Letter Carrier will put the stamps you requested in your postal box on the next regular delivery date.

MONTHLY SERVICE CHARGES

Each resident will be billed on the first of each month for the current month's service fee and any additional fees incurred during the prior month. Your monthly payment is due on the first of the month. We provide a 10-day grace period. Please place your payment in the Oaks Lodge or Lakeside Grand rent payment box. A late fee will be charged for all past-due payments. For your convenience, we offer an automatic payment option. If you would like your payment processed automatically (on or about the 10th, guaranteed no late fees if on the ACH program), please get in touch with **accounting** at ext. 235 (Oaks) and ext.254 (Lakeside) for an **Automatic Deduct form.**

NOISE

While you are free to enjoy a radio, stereo, television, piano, organ, etc. in your home, we kindly ask that you do not play them in a manner that would disturb your neighbor. Respecting your neighbors' peace is crucial for maintaining a harmonious community.

PARKING

Obey all signage. Visitors' boats, trailers, recreational vehicles, etc., cannot be parked on the premises. There are local businesses that provide rental space for such needs.

PET POLICY

Pets are wonderful companions and enrich their owners' lives. Research has revealed that pets positively impact their owners' health, and they may experience lower blood pressure and stress or a more robust immune system due to pet ownership. Waterman Village recognizes the therapeutic benefits of pet ownership and people's emotional attachment to their pets.

The pet policy applies to residents of Independent Villas, lakeside apartments, Custom Villas, Lakehouses, Manors, Estate Homes, and Garden Homes. Waterman Village retains the right to determine if a pet is appropriate for the setting in which it will live or visit. The pet owner is responsible for the pet's care, the pet's behavior does not infringe upon the rights of others, the pet meets legal requirements, and both the pet and its owner adhere to the policies of Waterman Village.

Details of Pet Policy and Pet Rules:

- Pet must comply with all government requirements;
- Pet must maintain up-to-date vaccination records;
- No more than two pets are permitted in any Waterman Village residence;
- Whenever weather allows, the pet should be exercised out of doors at least twice per day;
- A pet may not be left unattended on the grounds of Waterman Village;
- All dogs and cats must wear a tag with identification and must be leashed when outside the residence or fenced yard;
- Pet owners must pick up any "deposits" made by their pet(s);
- Excessive barking is prohibited both inside and outside the buildings;
- Pets must not inhibit employees from doing their jobs, and owners may be asked to temporarily remove a pet from a residence for completion of staff duties;
- Pets are not permitted in food preparation or dining areas (except for service dogs)
 THIS IS THE LAW;

- Owners must always be in control of their pets so as not to interfere with the safe ambulation of others;
- A resident of Waterman Village is responsible for any pet visitors bring on campus;
- A resident must have a Responsible Party on record that can be called to pick up and care for the pet in case of an emergency with the resident;
- No pet food, pet containers, or bed accessories are permitted outside any villa;

Waterman Village prohibits residents from owning and keeping the following dog breeds as pets on the Waterman Village campus: Pit Bull, Doberman, Rottweiler, Mastiff, Shar-Pei, Boxer, German shepherd, Husky, Great Dane, Dogo Argentino, Presa Canario, Cane Corso, Tosa Inu, Fila Brasileiro, Presa Mallorquin, Dalmatian, Chow, Akita, **and Wolf Hybrids. This rule applies to mixed breeds of these types and purebred dogs. Pets allowed are limited to dogs and cats.**

Please note: A person with a disability cannot be asked to remove his service animal from the premises unless (1) the dog is out of control and the handler does not take effective action to control it or (2) the dog is not housebroken. When there is a legitimate reason to ask that a service animal be removed, staff must offer the disabled person the opportunity to obtain goods or services without the animal's presence.

The ADA defines a service animal as any guide dog, signal dog, or other animal trained to assist an individual with a disability. If they meet this definition, animals are considered service animals under the ADA regardless of whether they have been licensed or certified by a state or local government. A service animal is <u>not</u> a pet, and Waterman Village is not required to care for or supervise one.

Fees: Before moving into Waterman Village, a non-refundable fee of <u>\$250.00 for the</u> <u>first pet and \$50 for the second pet is required</u>. Any charges associated with the pet, such as damage, pest control, or cleanup, will be charged to the resident by reducing their security deposit or entry fee. Legal or administrative costs incurred while seeking compliance with this policy will be charged to the owner. The resident will bear any charges for the care or placement of the pet while the owner is in Independent Living or another level of care.

Waterman Village requires all pet owners to carry liability insurance to cover any harm their pets cause. The minimum coverage required is \$300,000.00, which may be part of the resident's renters insurance.

Waterman Village requires all pet owners to provide copies of their pet(s) current vaccinations before moving in.

Waterman Village Engineering includes maintenance, grounds, and floor technicians. Work will be completed on a scheduled appointment, depending on the urgency, and the appointment may be rescheduled. We will do our best to respond to your needs as soon as possible, but we must list items in order of priority. Village personnel will always schedule contract technicians and coordinate repairs with the residents.

In case of emergency problems, such as broken water pipes, please immediately call the administrative assistant at ext. 251 to report the issue. If it's after 4:30 p.m. or on weekends, you can reach Security by calling ext. 382 (Oaks) or 383 (Lakeside).

We encourage you to personalize your apartment and make it your home. However, please note that any permanent changes to the appliances, doors, patios, and grounds must have approval from the Administration and the Engineering Department before being made or installed.

- Special requests involving skilled labor to include but not limited to: Electrical, Unit Enhancement, Carpentry, etc.
- Pricing is based on the scope of the request and is not due until all work has been completed.
- Scheduling of Plant Operation Support can be done by contacting the department at ext. 251 and will require a minimum of two weeks lead time before work begins.

<u>Appliances</u> - Each home has an electric range, refrigerator, heat pump, range hood, disposal, dishwasher, washer and dryer, and water heater. If you encounter any problems with these appliances, please notify the Engineering Department, and maintenance will be dispatched.

<u>Pest Control</u> - Each home receives outside pest control treatment every other month. If a problem arises, interior pest control is provided upon request. Residents do not need to remain in their apartments to receive this service.

<u>Trash Disposal</u> - Environmental Services will pick up trash throughout Waterman Village on Mondays, Wednesdays, and Fridays. Place all trash in the same bag(s). Items that can be recycled or burned for energy are separated at the Waste Center. Place tied trash bag(s) at the end of your driveway before 9 AM. Please do not leave it out the night before. Trash containers are not allowed. Please continue to break down your boxes

before placing them at the end of your driveway. Apartment residents, instructions are forthcoming.

Housekeeping

Our housekeeping staff will perform **light** housekeeping of your home bi-weekly. You will be assigned a specific day and time.

Each resident is asked to be ready to have their home cleaned on the scheduled date. Cooperation from each resident is essential to running a smooth cleaning schedule. If you cannot be home at your scheduled time, you may arrange with Environmental Services to have your home cleaned in your absence or skip until the following week. Standard Housekeeping

- Cleaning will be bi-weekly (or every other week).
- Timing of the cleaning is based on the square footage of the unit.
- Standard cleaning includes bathrooms, kitchens, and floors.
- Remaining time after standard cleaning is used at resident's discretion.

Supplemental Housekeeping

- Any Additional Cleaning activity inside or outside of the unit's allocated time.
- Cost for additional housekeeping services will be \$30 per 30 minutes.
- All Supplemental Housekeeping *must be schedules one week in advance of the service date*.
- Scheduling of Supplemental housekeeping service can be done by contacting the Housekeeping department at the Ext. 404

Resident Relations is a liaison between you, your family, visitors, and the health care professionals regarding any concerns. Resident Relations is also available to assist and provide emotional support.

Lifeline

Lifeline is a personal emergency response system that provides emergency assistance at the push of a button twenty-four (24) hours a day, seven days a week. Each resident will receive a lifeline button.

Instructions for Using Lifeline

Our goal is to answer all calls within 1 to 2 minutes. Occasionally, due to a high volume of calls, it may take slightly longer. Please be patient.

- Push your Lifeline button for at least a few seconds until the button vibrates and a red light blinks.
- A security Guard will call you on your phone. A security guard will go to your location if you do not answer the phone.
- If you accidentally push your lifeline button, Security will contact you to verify that you do not need assistance. Security will still need to go to the resident to deactivate the button.
- The Lifeline button will start flashing yellow when the battery is low. When that happens, call resident relations at 294 or 387 for a replacement battery.
- The personal Lifeline buttons are waterproof. Please wear them or have them accessible in the shower or bath.
- You may use your Lifeline for emergencies (Police, Fire, and Ambulance). Someone will respond to your apartment in minutes.
- We ask all residents to test their Lifeline equipment monthly by pressing the personal help button. When security asks for assistance, tell them you are testing the equipment. Quarterly testing is vital to the proper functioning of your Lifeline equipment. Should you have any questions regarding the procedure, please call ext. 294 or 387; our Lifeline Representative will assist you.

Non-Emergency Medical Procedures

- Call your physician.
- Follow their instructions.
- Your physician will decide if you remain in your residence or go to the hospital.

Please remember that you are expected to have a personal physician who will be qualified to handle your health needs.

Vial of Life

The vial of life is a mechanism used to provide accurate medical information to paramedics if you suffer a heart attack, stroke, or other disabling fall and cannot give information at that time. Waterman Village will provide a form and a vial to record all pertinent data. This would include insurance information and policy numbers, medications, known health problems, allergies, your doctor's name, the person to notify

in an emergency, and your healthcare surrogate's name and phone number. A healthcare surrogate is a relative or friend who can legally make decisions about your care when you cannot make those decisions yourself. You should also include in the Vial of Life a copy of your Living Will and the **yellow Do Not Resuscitate** order signed by your physician, if applicable.

A Waterman Village employee will usually help you fill out the Vial of Life form the first time. When completed, please place it in a safe place. We recommend putting it on the refrigerator door **(Do not place it in the freezer)**. The vial occupies little room and can readily be located without burrowing through files or desk drawers. The Lake County Sheriff's Office provides bright orange stickers to be placed on the outside of the refrigerator door and another on a window on or near the front door. If there are two of you in the apartment, you need two vials showing the medical history of each resident. It is a good idea to mark the outside of the vials with the person's name.

It is crucial to have this information readily available in an emergency. Should you need a new vial, forms, or assistance, please call (352) 383-0051, ext. 294 or 387.

SECURITY

Two Security officers are on duty 24 hours a day, seven days a week. If you inadvertently lock yourself out of your apartment, you may go to the gatehouse or call (352) 383-0051, ext. 382 (Oaks) and ext. 383 (Lakeside) so that the Security representative may assist you.

At your request, security will call your home to request permission to enter the house of guests who may wish to visit you. This can be arranged through Security at (352) 383-0051, ext. 382 (Oaks) and ext.383 (Lakeside). Also, if you expect deliveries, please notify Security.

To protect the residents and employees, the Village will only allow employees or tradespeople into an apartment to make deliveries or provide service with the resident's authorization (except in a true emergency). When authorized, a staff member from the Village will accompany the tradesman to the residence and remain while the work is done if required – and if available.

For security purposes, please do not admit anyone you do not know into your home. Also, please leave your outside light on during dark hours every night to help emergency service personnel locate your apartment quickly. Lock all doors and windows when you leave the apartment. A locked door is a deterrent to a potential problem. Should you need any assistance after 5:00 p.m. Please call (352) 383-0051 ext. 382

SMOKING POLICY

To comply with the Florida Clean Indoor Air Act (and to protect the health and safety of Waterman Communities, Inc. employees, residents, their guests, vendors, and other visitors), the company has adopted guidelines about smoking. Effective January 1, 2010, Waterman Communities implemented a campus-wide smoke and tobacco product-free policy for everyone – employees, residents, guests, visitors, and vendors – to provide a clean, healthy, productive, and safe environment.

Smoking Policy Interpretation and Implementation

- 1. This policy is in effect at all times while on the property and will apply to:
- a) All Waterman Communities employees at all facilities, on all shifts; and
- b) Residents, residents' guests, vendors, and visitors at all facilities.
- 2. Smoking and use of any tobacco products will be prohibited on all Waterman Communities-owned and leased locations; all internal and external public areas and parking lots; all entrances and exits of public buildings; all company-owned and leased vehicles; in personal vehicles while on company property; and, as a courtesy to our neighbors, in the back parking lot areas of the shopping plaza, which includes the restaurants, the Health Food Store, or any other commercial establishment that borders on the property of Waterman Village.
- 3. Smoking and using smokeless tobacco include, but are not limited to, inhaling, exhaling, burning, carrying, or possessing any lighted tobacco product, including cigarettes, cigars, pipe tobacco, or any other lighted tobacco product, chewing tobacco, or snuff.
- 4. Bridgewater Assisted Living Facility (ALF) residents, their family members, and guests must follow Waterman Communities, Inc.'s *Smoke and Tobacco-Free Campus Policy* while in the Bridgewater ALF, all public buildings, and the campus parking lots.
- 5. No ashtrays or other receptacles for tobacco products are permitted on campus.
- 6. Compliance with this policy is mandatory for all employees, residents, visitors, and vendors, with no exceptions. This prohibition against smoking and the use of any tobacco products shall apply at all times. Employees, residents, and their guests, visitors, and vendors will not be permitted to violate this policy. Individuals who violate the Florida Clean Air Act are subject to civil fines by Section 386-208 of Florida Statutes.
- 7. Smoking Cessation Opportunities. Waterman Communities encourages everyone who smokes or uses tobacco products to quit. The Waterman Communities Wellness Coordinator can provide information on cessation programs upon request. Questions regarding cessation programs should be directed to the Wellness Coordinator located in the Lodge.

Objectives and Services

The Chaplain's role is devoted to promoting the spiritual wellness of our residents and community. The Spiritual Wellness Department offers pastoral care through visitation and spiritual programming, contributing to shaping a caring community at Waterman Village.

We encourage our residents to be involved in the congregation of their choice. There is a weekly Interfaith Worship Service in the Garden of Life Fellowship Hall at 10:30 a.m. each Sunday. Everyone is invited to this inclusive Christian fellowship.

The quality of your spiritual life is essential to living at Waterman Village. The Garden of Life Fellowship Hall is open for meditation and prayer when not in use. A special prayer request can be placed on the communion table, which the chaplain will include in the prayer ministry. Please contact the Chaplain if there is any way you may be helped with your spiritual needs.

Caring Visitation

The Chaplain visits the residents' homes, at the hospital, during times of spiritual crisis, at the time of death, for funeral and memorial planning, and for pastoral counseling to help them cope with life's stressful situations. Appointments can be made to meet with the Chaplain by calling the Chaplain's office at your request.

Caring Programs for Heart and Soul

The Spiritual Wellness Department coordinates with the Activities Department to provide several programs for the residents of Waterman Village.

• <u>Sunday Worship</u>—10:30 a.m. in the Oaks Garden of Life Fellowship Hall. This worship is an inclusive Christian fellowship with a simple order of service. Communion is offered bi-monthly. A Love Offering is received each Sunday and used to help specific needs as proposed by the Spiritual Wellness Committee.

Caring Community

The Spiritual Wellness Committee, a volunteer group of residents, meets with the Chaplain each month to discuss and give guidance regarding spiritual programming and distribution of the Love Offering Fund.

The Chaplain collaborates with other pastors in the community. The Chaplain is also available to support and counsel staff and their families. The Chaplain serves on several committees and attends staff meetings as the Administration assigns.

Love Offering Fund

Love Offering donations are primarily collected from the weekly worship service offering. Donations are also received from residents at different times for memorials or special needs. The Spiritual Wellness Committee manages and authorizes spending on the Love Offering. The goal is that 50% of the offering will be used to encourage a number of caring organizations in Lake County (Food Pantry, Camp Challenge, Ruth's House, etc.). The remaining 50% is used for equipment and special needs within Waterman Village.

Since we are a 501(C) 3 not-for-profit tax-exempt organization, you will receive a tax deduction for your contribution. All donations are confidential per your desire for recognition.





VI. Marketing


